 vandalism after dark by younger people.
- Scenic natural streams, but no organized public area. Large summer crowds gather on local sand bars with
 no restrictions or regulations, causing law enforcement concerns and safety issues. No public, easily
 accessible boat launches on these streams and creeks because most lands are under private lease.
- Special Needs community has requested additional upgrades for the mobility impaired
- we are planning stages of construction of skate park and regional sports park
- We do not have needed facilities
- We have four parks and two boat launches, but none of these are easily accessible to pedestrians and bicyclists. Many residents say they would like more opportunities to walk safely to work or the post office and grocery. Other residents say they want a covered facility where they can walk or run laps. The recreation department is mostly accessed by car. There is a small sidewalk leading from a neighborhood to the facility, but it is isolated and overgrown with grasses and underbrush, so most parents don't let their children walk it alone.

Residents actually thought they had state-of-the-art facilities, although our gym was built in 1959, our pool in the 1930's, and most of our parks in the 1940's and 1950's. Until recently, these facilities had not been updated since that time.
- regional sports park will accommodate lots of amenities but total costs will require project be spread out over 10 or more years
- Sports Park director does not have public buy-in. Her vision is just that, hers.

Do you have any additional comments you would like to provide about outdoor recreation in Louisiana?

- Allen Parish has 2 scenic rivers with beautiful white sandy beaches. However, the only public access to the
 white sandy beaches is at the river crossing of La. Hwy 26 at the Calcasieu River and the Ouiska Chitto River.
 There is no structured activities or rules that monitor the glass, drinking, or parking and this has been the
 site of some bad behavior. Seems that the crossing at the Calcasieu Bridge would make an ideal State Park
 with camping, RVing, and family activities including swimming.
- As a rule, the state parks and recreations around the state are clean and well run and maintained. This takes
 a lot of effort and funding on the state's part, but it is a facet of our state that many visitors enjoy the most.
 Allen Parish has two well known scenic streams, but only one offers private canoe opportunities for summer
 recreation (Ouiska Chitto Creek). The Calcasieu River between Oakdale and Kinder has beautiful white silica
 sand bars up and down the river, but not a lot of public access except at the State Hwy 26 bridge just west of
 Oberlin. That large sandbar is very popular in the summer, but not well maintained and no regulations. It
 would seem to be an ideal site to locate a State Park in view of the expected population growth in the next 5
 years in conjunction with industrial development in Southwest Louisiana. Hwy 26 is also a recognized state
 biking route thru the state and the biking path crosses at that Hwy 26 bridge as it continues on through Allen
 Parish.
- Development of outdoor recreation in Louisiana must become a top priority for the state known as the 'Sportsmans Paradise'. This will require much more funding being available for local agencies to access.
- Fishing and hunting, rodeo, 4H are important aspects for rural America. Activities need to be addressed differently than from urban areas.
- Focus educational programs and activities for greater awareness of importance of outdoor recreation facilities.
- Having an indoor, air conditioned facility in West Feliciana Parish would fill a void and would improve WFPR reach for more participation.
- I want to commend those responsible for the state park system. I recently rented a cabin at North Toledo Bend state park and I was extremely impressed with the cleanliness and maintenance of the entire park! Keep up the great work!
- MANY SMALL TOWNS DO NOT HAVE ADEQUATE FUNDS TO PROVIDE THEIR RESIDENTS WITH THE VARIETY OF FACILITIES FOR RESIDENTS, ALL WE HAVE IS A PLAYGROUND AND A FEW PICNIC TABLES. WE WOULD LOVE TO AFFORD BIKE TRAILS, WALKING TRAILS, COURTS, AND SKATE PARK BUT NOT POSSIBLE
- * More rentals must become available. Water ski, boats etc are hardly accessible unless one knows someone


Do you have any additional comments you would like to provide about outdoor recreation in Louisiana?

- The Ouachita Parish Police Jury as a body does not collect any tax dedicated for recreational purposes.
- The parish is working to expand and improve boat access, the general public perception is that the number, location, and quality of boat launch facilities is inadequate.
- There needs to be more services provided to the rural areas of the state. You hear of lots of new activities
 and facilities being built in and around the major cities, but it seems to be assumed that families in the more
 rural areas have more access to outdoor activities. The fact is that most of that land is own by private
 citizens and the general public does not have access to it. I would like to see more hunting and fishing
 services provided that focus on getting kids involved. Just because families live in a rural/country area, it
 does not mean they have easy access to places to bring their kids to enjoy the outdoors.
- This survey only includes North LA Refuges Complex in Northeast Louisiana
- We are in the planning stages of building a new 'one site' sports complex
- We are located in an area where there is little concern about the need for children to have a safe haven after school.
- We have been successful in past years working with Office of State Parks on grant applications and other
 programs and we appreciate it and look forward to more future partnerships and successes. I would like to

- With a few exceptions, it appears that on the local levels most communities are 20 years in arrears of the rest of the country as it pertains to recreation facilities and programming. However, on the State level, it appears that efforts are ongoing to ensure Louisiana has some of the best state parks in the country.

The comments about state parks were not very pertinent to this survey because state park facility providers were not polled.






How do you communicate with residents in your community?

Portion of Public Recreation Places that Meets ADA Standards









Opportunities, Facilities, or Amenities Provided by Agency (% Responding Yes)











Bicycling Amenities Provided












Top Three Most Important Outdoor Rec. Facilities in Demand by Residents






Barriers to Recreation

Figure I.1: Emphasis Between Preservation/Protection and Outdoor Recreation





Figure I.2: Expenditure of Public Funds for Land Acquisition






Figure K.2: 2013 State of Louisiana Planning Region^{*} Population Breakdown by Age





Figure K.3: Ethnicity by Planning Region*




Figure K.5: Annual Household Income Distribution Statewide and in Louisiana's 8 Regions*




Figure K.6: Median Income in 2013 (Estimated based on 2010 U.S. Census)
