

**BOUNDARY MAP REQUIREMENTS FOR 6(f) DESIGNATION: The area subject to Section 6(f) protection will be the park, open space or recreation area being developed or expanded. (See Manual, Chapter 6-3, #5). Does the area the 6(f) boundary encompass a viable recreation area, i.e., is it capable of being self-sustaining without reliance upon adjoining or additional areas not identified in the project scope? Will it be an obvious public recreation area?**

**1.1** Provide a map of the designated area -Section 6(f) boundary intended for Land and Water Conservation Fund protection. The land designated by red boundary line on this map must stay in outdoor recreation use in perpetuity according to Federal Law 88-578, Section 6(f) and the public must have direct access to the property and its facilities within the LWCF 6(f) boundary.

**1.2** Outline the Section 6(f) Boundary with a BOLD RED line.

**1.3** Provide the property distance measurements in feet specifically for the Section 6(f) boundary.

**1.4** Label the street names near & adjacent to the property

**1.5** Label Lot and Block numbers.

**1.6** Provide metes & bounds, section, township & range with legal description and identify P.O.B. (Point of Beginning on survey).

**1.7** Provide legal description for the designated area. If 6(f) area is a portion and not the entire property as described in the original survey and property title, a new survey specifically for the 6(f) boundary will be necessary.

**1.8** Provide GPS coordinates for the entrance to property and identify location of coordinates (example: GPS coordinates for entrance sign).

**1.9** Provide latitude /longitude in degrees/minutes/seconds/direction. (No decimals)

**1.10** Provide acreage of area within proposed 6(f) Boundary.

**1.11** Identify vehicular & pedestrian access and parking for the recreation area within the 6(f) Boundary.

**1.12** Signature of sponsor's appointed authority – elected or appointed leader of sponsoring political subdivision shall sign and date the map **in blue ink**.

**1.13** Signature line for Division of Outdoor Recreation SLO or ASLO (**Mitchell Aleshire, ASLO**)

**1.14** Show the entire park or area being developed or acquired and the adjacent land uses (vacant, commercial, residential, industrial, rural). Label or identify LWCF 6(f) boundary.

**1.14** Provide map creation date, landscape architect, architect, engineer or surveyor's stamp

\* All information on map must be legible when printed at 8 ½ x 11 or 11x14 format.

**LEGAL DESCRIPTION** Required for Acquisition and Development Projects as well as Conversions.

Provide an exact legal description of the property to be acquired and or designated as 6(f) boundary. The legal description should coordinate with the legal survey information shown on the Boundary Map. Professional land surveys are not eligible for reimbursement. If 6(f) area is a portion and not the entire property as described in the original survey and property title, a new survey and Legal Description specifically for the 6(f) boundary will be necessary.
