LEGAL DESCRIPTION - PELTIER PARK

A certain tract or parcel of ground known as PELTIER PARK, containing 36.477 acres or 1,588,936 sq. ft., situated in Section 30 Township 15 South - Range 16 East, City of Thibodaux, Lafourche Parish, Louisiana, being more particularly described as follows:

Commencing at the intersection of the northerly right of way line of Belle Meade and the Easterly right of way line of Bayou Lane, said point being the Point of Commencement. Then, continuing along the easterly right of way line of Bayou Lane, North 15 degrees 58 minutes 02 seconds East a distance of 395.61 feet to a found 1" iron pipe, said point at the corner of Peltier City Park and the northwest corner of Belle Meade Subdivision also being the "POINT OF BEGINNING."

Then, North 16 degrees 01 minutes 31 seconds East a distance of 1,752.22 feet to a point;

Then, departing the right of way of Bayou Lane, South 76 degrees 41 minutes 42 seconds East a distance of 250.00 feet to a point;

Then, North 15 degrees 50 minutes 18 seconds East a distance of 12.24 feet to a point;

Then, South 77 degrees 15 minutes 35 seconds East a distance of 60.07 feet to a point;

Then, South 76 degrees 36 minutes 31 seconds East a distance of 344.35 feet to a point;

Then, South 15 degrees 51 minutes 24 seconds West a distance of 1,952.07 feet to a found concrete monument;

Then, North 64 degrees 22 minutes 26 seconds West a distance of 871.72 feet to the "POINT OF BEGINNING."
